[Characteristics]

- * **Hepalyse Plus II** is a drug in which liver hydrolysate, prepared by decomposing natural high quality liver to facilitate digestion and absorption, is the main ingredient.
- * This drug is effective as a nutritional supplement when you feel tired or your stomach and intestines are not in good condition because of frequent entertainment or overtime work.
- * Liver hydrolysate and inositol increase metabolism, and vitamins B₂ and E act as nutritional supplements.
- * This product is a reddish-brown sugar-coated tablet.

[Dosage and administration]

Take the following dose twice daily.

< Precautions of Dosage and Administration >

- (1) Follow the specified dosage and administration.
- (2) Take with or without food.

[Ingredients] Daily dose (6 tablets)

Ingredient	Amount	Function
Liver hydrolysate	600 mg	An ingredient prepared by decomposing natural high quality liver to facilitate digestion and absorption. It demonstrates nutritional fortifying effects by activating the liver metabolism.
Inositol	100 mg	It works with liver hydrolysate and exerts nutritional fortifying effects.
Vitamin B ₂ (riboflavin)	12 mg	These are vitamins essential for systemic metabolism.
Vitamin E Acetate	10 mg	

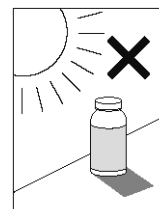
Excipients: D-mannitol, calcium silicate, carmellose calcium, magnesium stearate, gum arabic powder, crystalline cellulose, sucrose, hypromellose, pullulan, calcium sulfate, yellow iron sesquioxide, iron sesquioxide, red No. 3, blue No. 1, carnauba wax

< Precautions relating to ingredient and amount >

- Your urine may turn yellow after taking this drug, but this is due to the vitamin B₂ component, so there is no need to worry about it.

[Precautions for storage and handling]

- (1) Store in a cool, low humidity place away from direct sunlight.
- (2) Do not store in hot places. (Heat may cause cracking and discoloration of the tablets.)
- (3) Keep out of reach of children.
- (4) Do not transfer the medicine to a different container. (It may lead to misuse or alter the quality of the drug.)
- (5) After the filler in the bottle is discarded, the tablets can be damaged (chipping of the sugar coating) by an impact such as a fall. Handle the bottle with care.
You may notice the unique odor of liver hydrolysate when the container is opened.
- (6) This drug is a sugar-coated tablet. When water comes in contact with the tablet, the sugar coating on the surface may partially melt off, resulting in discoloration or unevenness. Do not handle the tablets with wet hands.
- (7) Do not take this product after the expiration date.
